ORDER

As per the Government Order read above, Government have accorded Administrative Sanction for the infrastructure developmental works of Government Arts & Science College, Chittur, Palakkad, for an amount of Rs.12,03,96,505.18/-, using the funds provided by Kerala Infrastructure Investment Fund Board (KIIFB) and the work should be executed through KITCO Ltd., as the Special Purpose Vehicle (SPV), for the project.

Now as per the letter read above, the Joint General Manager, KITCO Ltd., has informed that as per G.O (Ms) No.173/2019/H.Edn Dated, 19-06-2019, G.O (Ms) No.304/ 2019/H.Edn Dated, 30-08-2019, KSITIL has been appointed as the SPV for implementing the project and hence he has requested to change the SPV mentioned in the said Government Order as KSITIL instead of KITCO Ltd.

"The KIIFB works of Government Arts & Science College, Chittur, Palakkad shall be executed through KSITIL Ltd., as the Special Purpose Vehicle (SPV) of the project".
